# **Background and Authority**

The Administrative Office of the Courts (AOC) has the statutory responsibility of determining the qualifications and payment rates for all spoken language interpreters working in District, Metropolitan, and Magistrate courts throughout New Mexico (§38-9-7). The New Mexico Commission for Deaf and Hard of Hearing (NMCDHH) has the statutory responsibility to work in collaboration with the AOC to determine the requisite qualifications for signed language interpreters (§38-9-3). The following standards apply to interpreters working in all courts in New Mexico.

#### **Levels of Qualification**

There are three levels of signed language interpreter qualification. They are:

- Certified Interpreter: Legal Specialist
- Certified Interpreter: Legally Qualified
- Certified Interpreter: Legal Apprentice

The criteria for each category are on the next page. Interpreters must meet the established qualifications, pass a background check, and comply with continuing education and credential verification requirements.

# Municipal, Tribal, and Federal Courts

Courts that are not under the AOC jurisdiction coordinate their own interpreters, and may request a list of interpreters who meet the established qualifications from NMCDHH or from the AOC.
